MOBILE NOTARY SERVICE FOR SENIOR CARE CENTERS AND HOSPITALS.

We offer reduced price notaries for all Medical and Senior Care Centers in Federal Way, Puyallup, & Tacoma. The price is a flat fee of \$35 for Federal Way, \$40 for Tacoma, and \$45 for Puyallup care centers. The fee includes any powers of attorney forms needed. If you are needing a will notarized that requires witnesses, you will need to supply them. Staff at long term care centers cannot be a witness.

FORMS VS. SERVICES

We offer individual forms for you to complete on your own. We also offer document preparation services where we prepare the documents using a questionnaire that you will have completed and returned to us. An appointment will then be scheduled for signing and notarization. All Services that require a notary include the notary fee.

LAST WILL & TESTAMENT

A **LAST WILL & TESTAMENT** is a written document (testament) in which a person (the testator) directs how his or her assets (estate) are to be distributed upon death. Among other provisions, a will may appoint executors to administer the estate and name guardian(s) for a child. Usually, the law requires that the testator must have testamentary capacity when making the will, that it be witnessed by two or more credible witnesses and that it be notarized, though this varies state to state.

LIVING WILL

A **LIVING WILL** is a document that lets you determine what type of medical treatment you do or do not wish to receive if you happen to be too ill or injured to direct your own care. Among other things, a Living Will allows you to be sure that doctors do or do not “pull the plug”.

POWER OF ATTORNEY

A **DURABLE POWER OF ATTORNEY FOR FINANCES** is used primarily to give your named agent the power to deal with your assets in the event of your incapacity. It can also give your agent broad powers to dispose of, sell, convey, and encumber your real and personal property.

A **DURABLE POWER OF ATTORNEY FOR HEALTHCARE** is primarily intended to give your named Attorney-In-Fact the power to make medical decisions, sign consents and/or releases with hospitals and/or doctors.

- Full Service - \$24.95 - Includes Notary Service

A **SPECIAL (LIMITED) POWER OF ATTORNEY** allows (or authorizes) the person you name (i.e., your Agent, "attorney-in-fact") to perform a particular transaction. The Limited Power of Attorney restricts the authority of the Agent to a specific situation, limited time-period, or type of legal action.

Generally, a Limited Power of Attorney is used for the sale of real or personal property, but it can cover any specific situation or need that may exist. For example, if someone has moved out of state and wants to sell their house without returning to the state (just to sign the real estate documents for closing a transaction), they may grant a Limited Power of Attorney for that purpose only.

A **REVOCAION OF POWER OF ATTORNEY** is primarily intended to revoke a prior Power of Attorney.

CHILDCARE—POWER OF ATTORNEY

AN **AFFIDAVIT AUTHORIZING FOR MINOR TO TRAVEL** is primarily used to give your named Attorney-In-Fact the power to travel abroad with your minor child.

A **LIMITED POWER OF ATTORNEY FOR CHILDCARE** is used primarily to give your named Attorney-In-Fact the power to enroll your child in school or to obtain medical attention when you are not available.

A **MEDICAL CONSENT OF PARENT FORM** is used primarily to give your named Attorney-In-Fact the power to make medical decisions for your child when you are unable to.

TRUSTS

A **REVOCABLE LIVING TRUST** transfers all your assets into the name of a living trust while you are alive. After your death, these assets will be automatically transferred to your beneficiaries without going through the probate process. You can add assets to the living trust throughout your lifetime and you can amend or revoke the trust at any time.
