MOBILE NOTARY SERVICE FOR SENIOR CARE CENTERS AND HOSPITALS.

We offer a reduced-price mobile notary service (includes our power of attorney for healthcare and/or power of attorney for finances or your documents) for all Medical and Senior Care, Rehabilitation Centers in Auburn, Des Moines, Federal Way, Kent, Milton, Puyallup, Renton, Tacoma, and surrounding areas. The price is a flat fee of \$35 for Federal Way, \$40 for Auburn, Tacoma, Milton & Des Moines, \$45 for Puyallup and \$50 for Renton care centers. If you are needing a Last Will & Testament or Trust notarized that requires witnesses, you will need to supply them and there is an additional \$20 fee. Staff at long term care centers cannot be a witness. Most hospitals allow their staff to be a witness. Regular hours for these appointments are M - F 10 am - 3 pm; outside of these hours we charge an additional \$20.

ONLINE vs. IN-OFFICE SERVICES

Online services: Many of our services can be completed online. Just fill in your information on a service page or download a questionnaire to complete and return to us by way of fax, mail, secure email or in person at one of our offices. Within 24 hours of receiving your questionnaire, we will complete your document(s), contact you to schedule a signing at one of our offices or return to you your documents via secure email or priority mail.

In-office services: If you prefer to sit with a paralegal and complete your questionnaire you may do so at no additional cost to you. Typically, the documents will need 24 hours for completion and signing.

NOTARY FEES

In-store notarizing is available at our Federal Way office during regular hours. No appointment is required.

We do not supply your witnesses (as is required for a Last Will & Testament) unless you purchase our full service, so please plan and bring them with you.

We charge \$10.00 per signature for your form and \$8.00 per signature when you purchase our forms. If you purchase a service that requires a notary, one will be provided at no additional cost at our Federal Way, Sumner or Tacoma offices.

Mobile notary: We offer a mobile notary service for Western Washington. We charge a one-way trip fee from either office at \$2.00 per mile plus the Notary Fee. Minimum trip fee is \$25.00 plus notary fee. *For Senior Care Center prices see back of this pamphlet.*
